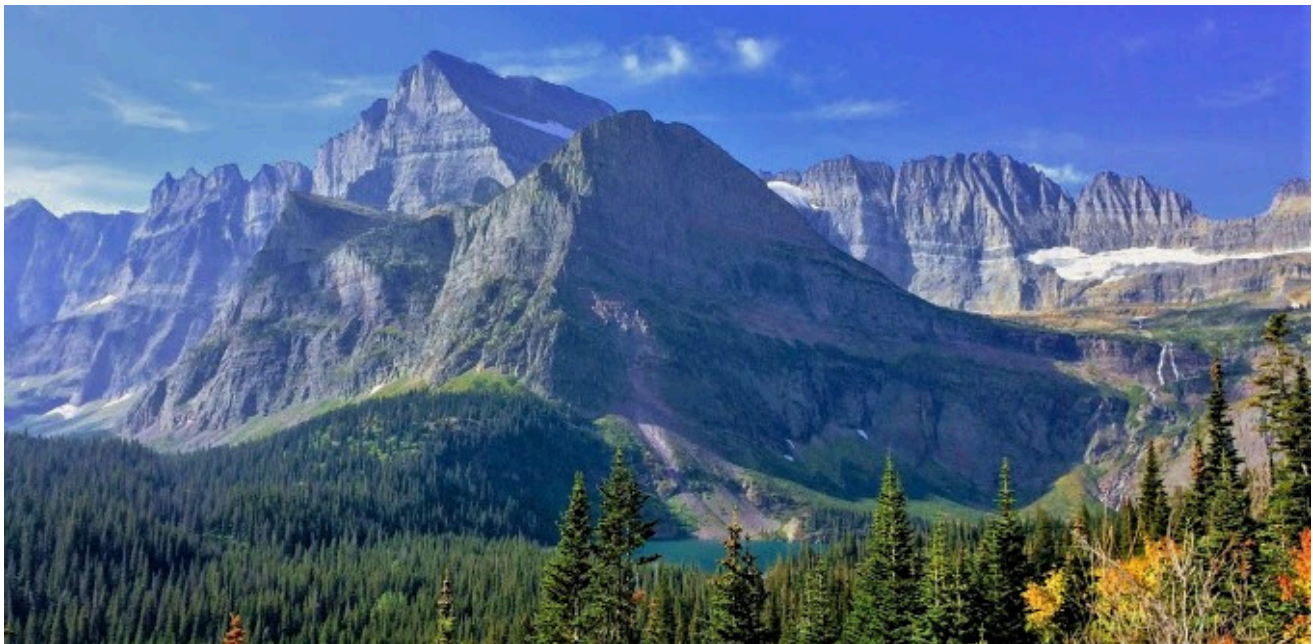


Northern Rockies Region Overview and FAQ

The Northern Rockies office is based in Kalispell, MT. Kalispell is surrounded by thousands of acres of picturesque public lands, including three impressive wilderness areas, Glacier National Park, and numerous state parks. The city serves as the hub of the Flathead Valley, which sustains one of the fastest-growing populations in the state. The demand for outdoor recreational venues and facilities is significant, which makes MCC's services that much more relevant. While crews complete projects throughout Northwest Montana, each corner of this landscape offers something different - from remote untrammelled rain forest to rugged mountain tops and deep canyons, to wild rivers.

HOUSING IN KALISPELL

Members serving in Kalispell will have the option to rent their own room in town, stay at an older Forest Service facility leased by MCC, or camp on their own at many dispersed campsites in the region. THE RAVEN

The Raven is a historic Forest Service Property leased by MCC in order to provide housing and camping options for our participants. While this provides valuable housing options for our participants, it is far from our main office. The drive is 50 minutes in good weather and traffic along a two-lane mountain road with lots of wildlife. The folks who have chosen to live at the Raven in the past have often found a great sense of community and respite there, but there is no way around the added time and difficulty in its location. The Raven is a 40-acre facility with standard housing, bunk housing, and camping options available. In the early season, there is one building, the Ranger House, that has running water, heat, and all the standard amenities of a home. It has four bedrooms and has housed eight members in the past.

Prices:

- \$50 p/month for camping option
- \$150 p/month for a bunk space
- \$200 p/month for a semi-private bunk space

Spaces are based on interest and would likely be double-occupancy. Once the weather warms, we will open additional buildings for bunk and camping options. There is a group kitchen and bathroom facilities for those that opt for either. As this is still a Federal Forest Service property, there is no consumption of alcohol or drugs permitted on the property. This will be strictly enforced.
